- o Budget is on track with \$7,588 more revenue than expenses
- Had 7 home sales so far this year resulting in \$1,400 to revenues.
- Received late fee charge from overdue dues.
- Received personal contributions to landscaping of \$1,160.
- o Will not receive much income from interest as the \$ have been spent on the roads.
- \$45,000 in operating funds.
- o Road fund balance is \$11,014
- o Professional services: a bit higher-registration fee for a board seminar.
- o Board is considering an increase in dues for 2022 for road the fund.

Architecture-George Pavey

- o In March new guidelines were approved by the Board

- 905 Del Monte issues are ongoing. Another letter was recently sent indicating if no action is taken to fix the problem, THVI enforcement policies will be initiated.

 is some concern regarding the available caterers approved by GVR. This may limit
 THVI's catered dinners for social events.

Landscape-Tim Cooney

- o Committee landscape members now include: Tim Cooney; (Chair), Rick Olivera, Bob Laux Bachand, Gary Allan.
- Tim thanked Bob Laux Bachand & Rick Oliveira for all the work they did this summer especially given the aftermath of the monsoon.
- \$3000 remains in the landscaping budget
- o Tuesday work crews will begin on Thursday October 26 at 7:30. Meet at the shed.
- There was discussion regarding from some resident regarding waiting since last spring for work to be done. Tim will address these ongoing requests.
- Shawneen Schmitt requested that new plants be placed in areas of greatest erosion from the monsoon rains. Tim & committee will take under advisement.
- Bill indicated that we may have to bring in contactors to help with the landscaping work this season.
- o An email will be sent announcing the Landscape Crew's start and requesting volunteers.

- o Alegria project was completed in June during the hottest week of the summer.

Book Exchange-Renee Hengel

- Presented a very detailed project for establishing a "Free Library" stand on Topacios. This
 would be on common ground. This would be similar to the stand at Desert Meadows Park
 and in Continental Vistas.
- o A contractor would build and install the project.
- o Renee & other interested residents would maintain the stand
- The Board decided a designated committee would not be necessary for maintenance but it could be a responsibility of the landscape committee.
- The total cost would be \$995 and a \$500 contribution has already been made. A email will be sent to all residents seeking contributions for the remainder.
- All neighbors have been contacted and are in agreement with the project.
- Contributions will be sent to Sandy Cooney.
- A motion was requested by Renee in support of the project. A motion of support was made by Mark Spence and seconded by Sharon Gaiptman. The motion was passed by the board.
- Renee will draft a letter seeking contributions from all residents. The secretary will email to the HOA.

Social Gathering Area- Shawneen Schmitt

- Suggestion was made to create a social gathering area with a bench or table & chairs where those walking or using trail can rest. This might be located near the Free Library.
- Shawneen and the Social Committee will develop a proposal for the board.

• Speed Control-Bill Stephenson

- o Many concerns have been raised regarding speeding on Topacios and Alegria.
- This is a long-term issue but needs some resolution because of the number of residents of THVI and other neighborhoods walking the streets and roads.
- There was much discussion regarding the uselessness of stop signs or even speed limit signs mainly because of lack of enforcement when violated.
- Some agreement of those in attendance was that a speed bump at Topacios and Placita Topa would help slow down the traffic and a speed limit sign Alegria might help.

o Bill & others from the board will be attending a "Roads Forum" next month and will present information at the December meeting.

Bulletin Boards -Jackie Means

- o The bulletin Boards are in rough shape and need to be replaced.
- There was some discussion regarding the use of the boards and the consensus from the Board was that they should be used for THVI HOA related business only. They are not public bulletin boards.
